Committee Corner

Architectural Control Committee

Just a reminder to all Piney Z residents, that before you start any exterior modifications to your home or property, you should complete an Architectural Control Committee (ACC) request form, which can be found on the Piney Z website under documents. These requests cover such things as: painting the exterior of your home; putting up a fence or replacing a fence; adding an addition to the residence; adding a deck or rehabilitation to existing deck; replacing roof shingles. By submitting the ACC request form for review and approval, this will insure our community is maintained in accordance with our Covenants and Restrictions and keep our community beautiful.

Landscaping Committee

The Landscaping Committee has engaged an arborist to evaluate the health of a few questionable trees located on the Common Area throughout the neighborhood. There are several trees and limbs that were "pruned" and/or removed after Hurricane Michael. The recommendations will be discussed at the December meeting with necessary follow-through actions to be completed in the new year. Standards Committee

Just a couple of reminders about continuing situations in the neighborhood...

- 1. No overnight parking on the street is allowed.
- 2. Trash bins should be moved to their proper location by the day after collection day at the latest.

If a homeowner/resident receives a 1st violation letter, please comply in order to avoid a fine. A second violation within a year will result in a fine being levied.

Hearing Committee

If homeowners/residents continue to violate neighborhood regulations or fail to make corrections within the allotted time, a fine will be levied against them by the HOA Board. The homeowner/resident will be given an opportunity to state their case in front of the Hearing Committee. The Hearing Committee will then decide to approve or deny the HOA Board levy of fines against the homeowner/resident. If approved, fines will be assessed. If denied, the particular issue is dismissed.
